The Minnesota Gun Owners Caucus is Minnesota's largest grassroots defender of the Second Amendment — leading the fight in the courts, at the Capitol, and across our communities. We will never compromise on your rights, and we oppose every law or government action that infringes on peaceable gun owners.

The 2026 legislative session began Tuesday, February 17, 2026.

The Minnesota House opened in a 67-67 tie, with the MNGOP holding the Speaker's gavel under a power-sharing agreement. The Senate stands at a 34-33 DFL majority.

Here are some of the major bills moving this session.



HF 3433 / SF 3654 – SEMI-AUTOMATIC RIFLE BAN

- Total ban on the sale, transfer, and possession of **nearly all semi-automatic rifles.**
- “Grandfathered” firearms may not be transferred — even to family.
- Upon your death, they must be turned into police for destruction or moved out of state
- To keep them you need a state “certificate” with an unknown cost
- Warrantless home inspections for “safe storage.”
- These firearms are restricted to your home or a licensed firing range.



HF 3402 / SF 3714 – MAGAZINE BAN

- Total ban on magazines over 10 rounds.
- No grandfathering.
- Must be destroyed, surrendered to law enforcement, or removed from the state by July 1, 2026.



HF 3351 / SF 3549 – REPEAL OF STATE FIREARMS PREEMPTION

- Eliminates Minnesota's firearms preemption laws.
- Allows cities and counties to pass their own gun bans and carry restrictions.
- Creates a patchwork of conflicting laws across the state.
- Makes it nearly impossible for law-abiding Minnesotans to know where they stand.

These are just 3 of the dozens of anti-gun laws that have been introduced this session.
