



# What Is the Caucus?

The Minnesota Gun Owners Caucus is the trusted voice of Minnesota's gun owners, working to defend and restore the right to keep and bear arms.

We are nonpartisan and single-issue. We don't chase headlines or build mailing lists for their own sake. We show up at the Capitol every day the Legislature is in session, we sue when government oversteps, and we fight to elect leaders who will protect your rights. No other organization in Minnesota does what we do, the way we do it.

We win because we show up. Every time.

## WHAT WE'VE DONE

**We stopped every gun control bill in the past two years.**

We defeated the DFL's entire gun control agenda in both 2025 and 2026, including the massive semi-auto and magazine ban, and we shut down Governor Walz's push for a gun control special session.

### We litigated, and we won.

- **Worth v. Jacobson** — Struck down Minnesota's ban on permits to carry for 18-to-20-year-olds. The win held all the way up: the U.S. Supreme Court declined to disturb it. 18-to-20-year-olds can now carry in Minnesota.
- **Caucus v. City of Saint Paul** — Sued the City of Saint Paul to stop its illegal, preempted gun control ordinance. Local governments do not get to write their own gun laws.
- **Caucus v. Walz** — Sued Governor Walz and Attorney General Keith Ellison over the binary trigger ban. We won in Ramsey County District Court and again at the Minnesota Court of Appeals, striking the ban as unconstitutional under the MN Constitution's single-subject clause.
- **Dozens of amicus briefs** — Filed in critical Second Amendment cases across the country and before the U.S. Supreme Court, shaping the precedent that protects your rights here in Minnesota.

## Now we're focused on November.

The fight at the Capitol is decided at the ballot box. We are working to elect and protect pro-2A legislators, a pro-2A Attorney General, and a pro-2A Governor across Minnesota in the 2026 elections.

The future of your rights depends on who holds office.
